WHEREAS, Article XII, Section 6, of the 1987 Constitution states that, **"The State shall apply the principles of agrarian reform and stewardship, whenever applicable in accordance with law, in the disposition or utilization of natural resources, including lands of public domain xxx."**;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, provides that **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing the LGC of 1991 provides that, **"unless otherwise provided, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."**;

WHEREAS, Section 1, Article 20, Rule V of the Implementing Rules and Regulations of Republic Act No. 9994 or the "Expanded Senior Citizens Act of 2010" that pursuant to the eligibility criteria as may be determined by the DSWD, indigent shall be entitled to a monthly stipend amounting to Five Hundred Pesos (Php500.00) to augment the daily subsistence and other medical needs of the senior citizens;

WHEREAS, The Department of Social Welfare and Development (DSWD), as the lead agency in social welfare and development, implements the SPISC in the country and has then issued various guidelines, memoranda and administrative orders to respond to the issues and concerns encountered including among others: DSWD Memorandum Circulars: **No. 17 Series of 2021** (Amendment to MC No. 16 Series of 2021 for the Release of Social Pension from Quarterly to Semestral and Supplemental Provision to include Transfer of Funds to Local Government Units (LGU) and **No. 04 Series of 2019** (Omnibus Guidelines in the Implementation of Social Pensions for Indigent Senior Citizens);

WHEREAS, DSWD Memorandum Circular **No. 17 Series of 2021** mandated the agency to guarantee the most cost effective and efficient modality for distribution of the stipend to the beneficiary, which includes any of the four (4) delivery schemes: **(a) cash advance by a designated Special Disbursing Officer; (b) door to door delivery scheme; (c) cash card through authorized Government Depository Bank; (d) Money remittance;**

WHEREAS, supra, provides that, **the choice of applicable delivery scheme may vary periodically or may be combined considering the prevailing status, physical condition and geographical location of the senior citizen beneficiaries;**

WHEREAS, pursuant to the objective of fast-tracking the distribution and the given limitation on the fund of social pension, fund transfer to local government units may likewise be resorted to;

WHEREAS, the City Government of Muntinlupa (CGM), through its various departments, has implemented an efficient mechanism in delivering the cast pay-out to the social pension beneficiaries down to barangay level. In view thereof, the fund amounting to **Seventeen Million Eight Hundred Fourteen Thousand Pesos (Php17,814,000.00)** covering the 2nd semester FY 2022 and unpaid 1st and 2nd quarter FY 2022 based on the approved RAO and project proposal of DSWD-NCR for the implementation of Social Pension Program in accordance with existing accounting and auditing rules and regulations imposed by the Government and the COA No. 94-013 was transferred to the CGM and shall be disbursed in accordance with prevailing memoranda and guidelines;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** to enter and sign the **Memorandum Of Agreement (MOA)** with **Department of Social Welfare and Development (DSWD)** represented by its **Regional Director Monina Josefina H. Romualdez** on the delivery of **Social Pension to Indigent Senior Citizens (SPISC)** through Cash Advance, Door-To-Door Delivery, Cash Card, Fund Transfer and other pay-out schemes.

SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS



Indigent senior citizens shall be entitled to a monthly stipend amounting to Five Hundred Pesos (PhP500.00) to augment the daily subsistence and other medical needs of senior citizens

The Social Pension for indigent senior citizens is an additional government assistance mandated under Republic Act 9994 otherwise known as "The Expanded Senior Citizens Act of 2010

OBJECTIVE

To augment the daily subsistence and other medical needs of senior citizens

COVERAGE

The Social Pension for indigent senior citizens is implemented in all regions including Autonomous Region of Muslim Mindanao (ARMM)

ELIGIBILITY CRITERIA



Frail, sickly or with disability



Without pension from SSS, GSIS, or from any sources of pension in government and private agencies



Without permanent source of income, compensation or financial assistance from relatives to support basic needs

REQUIREMENTS



The senior citizen or his/her relative shall submit either a photo copy of any valid ID (indicating the birth date of the qualified beneficiary) or birth certificate of the senior citizen to the nearest Office of the Senior Citizens Affairs (OSCA) or City/Municipal Social Welfare and Development Office (C/MSWDO)






