WHEREAS, Article 86 (b)(1)(vi) and Article 86 (bX1)(viii) of the Local Government Code (LGC) of 1991, provides that, "the City Mayor shall represent the, city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations implementing the LGC of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, the National Government's project known as the Build, Build, Build Infrastructure Program foresee an efficient and coordinated transportation system. To attain this end, partnership between the Local Government unit (LGU), DOTr and PNR, is also being forged to protect and safeguard the interests of the affected constituents;

WHEREAS, the **North- South Commuter Railway Extension (NSCR-Ex) Project South Commuter** will be implemented with a **Resettlement Action Plan ("RAP")** that must strictly adhere to international social and environmental safeguards in the implementation of the project, which includes ensuring that **(a) adverse social and physical impacts are avoided, minimized, and/or mitigated, (b) project-Affected Persons (PAPs) benefit from the Project; (c) PAPs are provided with sufficient compensation and assistance for lost assets so that none of them shall be worse off because of the project;** and all stakeholders, especially PAPs, are duly consulted regarding the project's design, implementation, and operation;

WHEREAS, for purposes of complying with the above quoted **RAP**, it is imperative to establish a **RAP Implementation and Management Committee (RIMC)** which shall consist of representatives from DOTr, PNR, the LGU, and the group of PAPs, to ensure that all resettlement efforts related to the project are consistent with the RAP, related national and local laws, and international social safeguards;

WHEREAS, under the proposed MOA, the created RIMC, among other functions provided therein, shall function as the primary implementation arm in charge of aligning national and local policies with the requirements of the RAP;

WHEREAS, finding that the MOA is substantial both in form and provisions, the City Legal Office has no legal objection and recommended its adoption.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Rozanno Rufino B. Biazon** to enter into and sign in behalf of the City Government of Muntinlupa a Memorandum Of Agreement (MOA) with the **Department Of Transportation (DOTr)** represented by **Undersecretary for Railways, Cesar B. Chavez**, and the **Philippine National Railways (PNR)** represented by **General Manager Jeremy B. Regino** for the creation of a **Resettlement Action Plan Implementation And Management Committee (RIMC)**.

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 28th day of November 2022, on its 21st Regular Session.


