A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE (DA-RFO) AND THE BUREAU OF SOILS AND WATER MANAGEMENT (BSWM) ON THE ESTABLISHMENT OF COMPOSTING FACILITY FOR BIODEGRADABLE WASTES IN THE CITY OF MUNTINLUPA

WHEREAS, it is hereby declared the policy of the State to promote, propagate, develop further and implement the practice of organic agriculture in the Philippines that will cumulatively condition and enrich the fertility of the soil, increase farm productivity, reduce pollution and destruction of the environment, prevent the depletion of natural resources, further protect the health of farmers, consumers, and the general public, and save on imported farm inputs. Towards this end, a comprehensive program for the promotion of community-based organic agriculture systems which include, among others, farmer-produced purely organic fertilizers such as compost, pesticides and other farm inputs, together with a nationwide educational and promotional campaign for their use and processing as well as adoption of organic agriculture system as a viable alternative shall be undertaken;

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **“every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."**;

WHEREAS, Republic Act 10068 otherwise known as **"Organic Agriculture Act of 2010"** created a National Organic Agricultural Program, with the National Organic Agricultural Board as implementor tasked to constantly devise and implement ways and means not only of producing organic fertilizers and other farms inputs and needs on and off the farm but also of helping to alleviate the problems of industrial waste and community garbage through disposal through appropriate methods of sorting, collecting and composting;

WHEREAS Republic Act 11511 also known as the Act amending RA10068 provides for the Promotion and encouragement of the establishments of facilities, equipment and processing plants that would accelerate the production and commercialization of organic fertilizers, bio-control agents, organic soil amendments and other appropriate farm inputs;

WHEREAS, the **Bureau of Soils and Water Management (BSWM)**, proposed the establishment in the City of Muntinlupa a Composting Facility for Biodegradable Wastes (CFBW) through the provision of equipment such as **One (1) unit Bio-mass shredder machine** and **One (1) unit Rotary composter**, as well as the transfer of technical know-how;

WHEREAS, the City Legal Office has no objection to the MOA, subject to pertinent rules and guidelines on receipt and accounting of properties and compliance with the obligations under the MOA particularly on the utilization and safekeeping of the CFBW and the regular submission of data;

NOW, THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** to enter and sign the memorandum of agreement (moa) with the department of agriculture regional field office (da-rfo) and the bureau of soils and water management (bswm) on the establishment of composting facility for biodegradable wastes in the city of muntinlupa

ADOPTED, by the 10th Sangguniang panlungsod of Muntinlupa this 5th day of December 2022, on its 22nd Regular Session.




