WHEREAS, Section 455 (b)(1)9(vi) of the Local Government Code provides that, *"The City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod"*;

WHEREAS, partnerships and joint ventures between **public and private sectors** are encouraged under the law as it will not only enhance the development and progress of the LGUs but likewise foster goodwill and cooperation;

WHEREAS, Lalamove Philippines, Inc, (Lalamove), is an on demand delivery company which uses an application at the touch of a button where users could gain access to a wide fleet of suitable delivery vehicles. Having been a partner for businesses to solve last-mile delivery needs, Lalamove harnessed the possibility of providing livelihood to Muntinlupa City residents through a Memorandum of Agreement (MOA) whereby Lalamove will be accrediting capable and professional drivers who shall be known as **verified partner-drivers**;

WHEREAS, the MOA provides among others: the term of which is for one (1) year only; the **Muntinlupa-resident verified partner-driver** is not an employee of Lalamove nor the City Government; compliance with the Data Privacy Act of 2012; administrative requirements for both parties and mobilization through use of website and social media of the City;
