WHEREAS, Republic Act 7160, also known as the **Local Government Code of 1991** provides that, *"Each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian. For this purpose, the development council at the x-x-x city level, shall assist the corresponding Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction"*;

WHEREAS, under a **Memorandum Circular dated July 18, 2019** issued by the **Department of Interior and Local Government (DILG)**, the guidelines in the formulation of the **Executive Legislative Agenda (ELA)** was prescribed underscoring the importance of the unifying document that is developed and mutually agreed upon by both the executive and legislative departments of a local government unit;

WHEREAS, the **Comprehensive Development Plan (CDP)** which contains the vision, sectoral goals, objectives, development strategies and policies within the term of the LGU officials is a product of a multi-sectoral initiative and is the basis in the analysis of the LGU's situation;

WHEREAS, the **Executive-Legislative Agenda (ELA)** is a term-based, mutually developed and agreed document that is culled from the LGUs Comprehensive Development Plan and highlights the LGUs vision, mission goals, objectives, strategies, platform of governance of the executive, and priority legislative agenda of the Sanggunian;
