A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON TO ENTER INTO A CONSTRUCTION AGREEMENT WITH RS CIRCLELINK CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF PET CREMATORIUM LOCATED AT PACWOOD, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION, SIX HUNDRED NINETY-EIGHT THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS AND 88/100 (PHP2,698,888.88) WHICH AMOUNT SHALL BE TAKEN FROM THE 2022 SUPPLEMENTAL BUDGET NO. 4 (ORDINANCE NO. 2022-011) UNDER INFRA-FUND

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "**Xxx Authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others**";

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, "**The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

WHEREAS, pursuant to RA 9184 otherwise known as the Procurement Law, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **construction of Pet Crematorium located at Pacwood, Barangay Tunasan, Muntinlupa City**. The same project was likewise posted continuously for seven days at the *Philippine Government Electronic Procurement System (PhilGEPS)*, city's website and conspicuous places within the premises of the City Government of Muntinlupa;

WHEREAS, in response to the said advertisement/s and publication, one (1) bidder submitted its letter of intent and application for eligibility:

WHEREAS, the aforesaid bidder submitted its bid on **November 8, 2022** and passed the Preliminary Examination of Bid conducted at the City Administrator's Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa;

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements, **RS Circlelink Construction Corporation's** bid was adjudged to be responsive to the **Approved Budget for the Contract (ABC)** amounting to **Two Million Seven Hundred Forty-Two Thousand Sixteen Pesos and 10/100 (Php2,742,016.50)**. Thereafter, the project was awarded to **RS Circlelink Construction Corporation's**, as the lowest bidder for the project *construction of Pet Crematorium located at Pacwood, Barangay Tunasan, Muntinlupa City*;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th **Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **RS Circlelink Construction Corporation** for the project *construction of Pet Crematorium located at Pacwood, Barangay Tunasan, Muntinlupa City* in the amount of **Two Million, Six Hundred Ninety-Eight Thousand Eight Hundred Eighty-Eight Pesos And 88/100 (Php2,698,888.88)** which fund shall be taken from the **2022 Supplemental Budget No. 4 (Ordinance No. 2022-011) Under Infra-Fund**.
