**WHEREAS**, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "**Xxx Authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others**";

**WHEREAS**, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, "**The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

**WHEREAS**, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Installation of Fiber Optic Cables at various Satellite Offices of the City Government (BPLO, City Treasury, Satellite Office, MCMAO, Police Clearance, PDAO, MTMB and NBI) located at Ayala Mall, Barangay Alabang, Muntinlupa City**, and likewise posted the same at the Philippine Government Electronic Procurement System (PhilGEPS), City's Website and conspicuous places at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in response to the said advertisements, two (2) bidders submitted their letter of intents and application for eligibility:

**WHEREAS**, one (1) Bidder submitted its Bid on **November 8, 2022** and such bidder passed the Preliminary Examination of Bid conducted at the City Administrator's Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa;

**WHEREAS**, after careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with the lowest calculated bid, **V.F. Labao Construction Corporation's** bid was found to be responsive to the **Approved Budget for the Contract (ABC)** amounting to **One Million Seven Hundred Twenty Thousand One Hundred Twenty-Four Pesos and 73/100 (Php1,720,124.73)**;

**WHEREAS**, the project was awarded to **V.F. Labao Construction Corporation**, who was adjudged as the lowest bidder for the project **Installation of Fiber Optic Cables at various City Government Satellite Offices (Business Permits and Licensing Office, City Treasury, Satellite Office, Muntinlupa City Muslim Affairs Office (MCMAO), Police Clearance, Persons with Disability Affairs Office, Muntinlupa Traffic Management Bureau and National Bureau of Investigation)** located at **Ayala Mall, Barangay Alabang, Muntinlupa City**;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **10<sup>th</sup> Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon**, to enter into a Construction Agreement with **V.F. Labao Construction Corporation** for the project **Installation of Fiber Optic Cables at Various City Government Satellite Offices** located at **Ayala Mall Alabang, Muntinlupa City** in the amount of **One Million, Seven Hundred Ten Thousand Pesos (Php1,710,000.00)** which amount shall be taken from the **2022 Supplemental Budget No. 4 (Ordinance No. 2022-011)** under **Infra-Fund**.

**RESOLVED FURTHER**, that the authority herein granted to the the **City Mayor Hon. Rozzano Rufino B. Biazon** is based on the evaluation of documents submitted by the Bids and Awards Committee (BAC);






