**WHEREAS**, Republic Act No. 7796 otherwise known as the TESDA Act of 1994, declares that it is the policy of the State to, ***“Promote relevant, accessible, high quality and efficient technical education and skills development in support of the development Filipino middle-level manpower responsive to and in accordance with Philippine Development goals and priorities. The State shall encourage active participation of various concerned sectors, particularly private enterprises, being direct participants in and immediate beneficiaries of a trained and skilled workplace, in providing technical education and skills development opportunities;”***

**WHEREAS**, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, also known as the Local Government Code (LGC) of 1991, provides that ***“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;***

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing LGC of 1991 provides that, **"Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."**;

WHEREAS, JLO & Daughsons, Inc., an employment agency, is a corporation duly organized and existing under and by virtue of the laws of the Philippines, herein represented by its President Mr. Renzo B. Mercado, with office address located at Block 2 Lot 1, Gigatech Building, Mon El Subdivision, Parañaque City

WHEREAS, Muntinlupa City Technical Institute (**MCTI**) is duly recognized by the **Technical and Skills Development Authority (TESDA)**, and the TVET arm of the City Government, partnered with the JLO & Daughsons, Inc. to ensure the employment opportunities for the graduates of MCTI most specially those who trained for the electrical program;

WHEREAS, the City Legal Office (CLO) suggested that the following clauses be included in the MOA:

a. **The parties hereto agree and ensure that the consent of the data subjects to the processing and sharing of their personal information were validity obtained;**

b. **The agency hereby agrees that all data obtained arising from this MOA shall be used only for the purpose of securing employment opportunities for the data subject and for no other purposes;**

c. **The parties hereto adopt the general data privacy and data sharing principles declared in the Data Privacy Act and its and its IRR and adhere to the principles of transparency, legitimate purpose, and proportionality in the processing of personal data under this MOA.**

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to grant authority to the City Mayor Hon. Atty. Jaime R. Fresnedi to enter into a Memorandum Of Agreement for the Muntinlupa City Technical Institute (Mcti) with Jlo & Daughsons, Inc., represented by its president, Renzo B. Mercado on the referral of MCTI graduates for possible local employment.
