PATALINHUG REGIONAL DIRECTOR ON THE IMPLEMENTATION OF THE EMBROIDERY MACHINE FOR INDUSTRIAL SEWING MACHINE OPERATION (ISMO) AND DRESSMAKING COURSE AT MCTI AND THE PROVISION OF QUALITY TECHNICAL EDUCATION ON INDUSTRIAL SEWING MACHINE OPERATION

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **"Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."**;

WHEREAS, Republic Act No. 7796, declares it a policy of the State to, **"promote relevant, accessible, high quality and efficient technical education and skills development in support of the development Filipino middle-level manpower responsive to and in accordance with Philippine Development goals and priorities. The State shall encourage active participation of various concerned sectors, particularly private enterprises, being direct participants in and immediate beneficiaries of a trained and skilled workplace, in providing technical education and skills development opportunities;"**

WHEREAS, DOST-NCE's core function is to plan and implement programs and projects on Research and Development, technology transfer and the delivery of Science and Technology service and develop institutional linkages with Regional Offices, other agencies, and local government and private organizations or entities for the effective planning and implementation of Science and Technology;

WHEREAS, MCTI is mandated to provide quality technical, vocational education, entrepreneurial training and promotion of programs of the city government;

WHEREAS, the MCTI has opened a course on Industrial Sewing Machine Operation (ISMO) to address the needs of the garment sector and to support Muntinlupa City's livelihood program;

WHEREAS, the DOST-NCR will install a computerized embroidery machine in MCTI for the use and benefit of MCTI sewers and trainees from Southville 3, Barangay Poblacion, Muntinlupa City;

WHEREAS, the equipment has an assessed value of *Five Hundred Ninety Thousand Eight Hundred Fifty-Nine Pesos and 10/100 (Php590,859.10.)* MCTI is obliged to provide counterpart funding in the amount of *Six Hundred Thirty-Eight Thousand Five Hundred Seventy-Four Pesos and 25//100 (Php638,574.25)* and maintenance service to the equipment;

WHEREAS, the project duration shall be completed within a period of twelve months to commence immediately following the successful installation of the equipment on December 2021 up to November 2022;

WHEREAS, the project is Embroidery Machine for Industrial Sewing Machine Operation (ISMO) and Dressmaking Course at MCTI;

WHEREAS, the City Legal Office interposes no objection to the MOA revised and amended as suggested, reserving the right to comment on the eventual MOA;

NOW THEREFORE, BE IT RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter into a Memorandum of Agreement (MOA) to represent the **MCTI** with the **DOST-NCR** represented by **Jose B. Patalinhug Regional Director** on the implementation of the **Embroidery Machine for Industrial Sewing Machine Operation (ISMO)** and **Dressmaking Course** at MCTI and the provision of quality technical education on **Industrial Sewing Machine Operation**.






