WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **perimeter fence** for the **New Senior High School Building** located at **Muntinlupa National High School (MNHS), Southville III, Barangay Poblacion, Muntinlupa City** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **January 20, 2021**;

WHEREAS, there is one (1) Bidder who submitted Bid on **January 20, 2021** and Passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Ayana Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Three Million Five Hundred Twenty Thousand Three Hundred Seventy-Three Pesos and 33/100 (Php3,520,373.33)**;

WHEREAS, the project was awarded to **Ayana Construction Corporation**, who being the lowest bidder for the project **perimeter fence** for the **New Senior High School Building** located at **Muntinlupa National High School (MNHS) Southville III, Barangay Poblacion, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Ayana Construction Corporation** for the project construction of perimeter fence for the **New Senior High School Building** located at **Muntinlupa National High School (MNHS) Southville III, Barangay Poblacion, Muntinlupa City** in the amount of **Three Million Five Hundred Ten Thousand Two Hundred Sixty And 5/100 (Php3,510,260.05)** which amount shall be taken from **2021 Local School Board Fund**.




