WHEREAS, there one (1) Bidder submitted their Bid on **January 20, 2022** and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Gemwealth Construction & Trading's** its bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **One Million Eight Hundred Forty-Nine Thousand Two Hundred Eighty Pesos and 30/100 (Php1,849,280.30)**;

WHEREAS, the project was awarded to **Gemwealth Construction & Trading** who being the lowest bidder for the project **installation of additional streetlight post** located at **West Service Road, Muntinlupa City**;
