**WHEREAS**, the Southeast Asian Games, also known as the **SEA Games**, is a biennial (every odd-year) multi-sport event involving participants from the current 11 countries of Southeast Asia. The games are under the regulation of the Southeast Asian Games Federation with supervision by the International Olympic Committee (IOC) and the Olympic Council of Asia (OCA);

**WHEREAS**, one of the regulated games in the SEA Games participated by the Philippines is Ju-Jitsu, a Japanese martial arts and a system of close combat (unarmed or with a minor weapon) that can be used in a defensive or offensive manner to kill or subdue one or more weaponless or armed and armored opponents. This form of martial arts uses few or no weapons at all and includes throws, holds, and paralyzing attacks against the enemy;

**WHEREAS**, the discipline was initially introduced as part of the competition in the **SEA Games** in 2019 where **Annie Ramirez, a Muntinlupeño**, bagged the gold medal;

**WHEREAS**, thereafter, **Annie Ramirez** successfully extended her reign in the **Women's under 62 kilogram category in the 2021 SEA Games** held in Hanoi, Vietnam after outlasting her opponent from Thailand in the final round;

**WHEREAS**, such a feat, achieved through perseverance, hard work and patience, is worthy to be replicated and be the goal in the sports development of the Muntinlupa athletes;






