WHEREAS, the Bureau of Local Government Finance Memorandum Circular No. 07-01-2017 provides that, **"LGUs specifically allowed by law, rules and regulations to retain income and/or for operations and/or working balances, shall deposit and maintain Government Funds with any of the following banks:**

WHEREAS, on January 25, 2007 Resolution No. 07-368 authorizing the City Mayor Atty. Jaime R. Fresnedi to transfer the account of Ospital ng Muntinlupa to Philippine Veterans Bank and to enter into a payroll servicing agreement, was adopted by the Sangguniang Panlungsod;

WHEREAS, the previous Memorandum of Agreement needs amendment to include the mandated provisions of RA 9160, RA 10173 and other issuances of the Bangko Sentral ng Pilipinas;

NOW THEREFORE, BE IT RESOLVED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to sign and enter into an amended Memorandum of Agreement with the Philippine Veterans' Bank (PVB) represented by **Mirella S. Valverde**, Southern Metro Manila Area Head and **Portia V. Samano**, PVB Muntinlupa Branch Head in order to include provisions required by Republic Act (RA) 9160, otherwise known as the **Anti-Money Laundering Law**, as amended, RA 10173 also known as the **Data Privacy Law** and Other Issuances by the Bangko Sentral Ng Pilipinas.

ADOPTED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 23<sup>rd</sup> day of May 2022, on its 149<sup>th</sup> Regular Session.






