WHEREAS, Republic Act 10121, otherwise known as the Philippine Disaster Risk Reduction and Management (DRRM) Act, adopts the **“policy of a DRRM approach that is holistic, comprehensive, integrated and proactive in reducing the socioeconomic and environmental impacts of disaster including climate change and promote involvement and participation of all stakeholders and all sectors concerned, at all levels, especially the local community”**;

WHEREAS, on August 30, 2016, the **National Disaster Risk Reduction and Management Council (NDRRMC)** and the **National Security Council** issued Joint Circular 01-2016 providing for the Guidelines on the Formulation of Contingency Plans for Natural and Human-induced Hazards and Adoption of Contingency Planning Guidebooks;

WHEREAS, as defined by RA 10121, “Contingency Planning is a management process that analyzes specific potential events or emerging situations that might threaten society or the environment and establishes arrangements in advance to enable timely, effective and appropriate responses to such events and situations”.

WHEREAS, on 21st May 2018, the City Council adopted Resolution No. 18-306 ratifying the Muntinlupa Contingency plan for Earthquake;

WHEREAS, Resolution 18-306 was adopted before the onset of the 2019 Pandemic brought about by the Covid-19 virus hence, the necessary protocols and guidelines needed to be implemented were not included in the 2022 Contingency Plan for Earthquake;
