A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ATTY. JAIME R. FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE LAGUNA LAKE DEVELOPMENT AUTHORITY (LLDA) REPRESENTED BY GENERAL MANAGER JAIME C. MEDINA ON THE PROVISION OF TEN (10) UNITS OF SOLAR POWERED PADDLE WHEEL FOR THE IMPLEMENTATION OF "INTRODUCTION OF NUTRIENT LIMITING MECHANISMS TO PREVENT ALGAL BLOOM IN LAGUNA LAKE"

WHEREAS, Section 7, of 1987 Philippine Constitution, states that, "xxx. The State shall protect of subsistence fishermen, especially of local communities, to the preferential use of the communal marine and fishing resources, both inland and offshore. Xxx. The state shall also protect, develop and conserve such resources."



WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.",

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";

WHEREAS, Laguna Lake Development Authority (LLDA) a government owned and controlled corporation created by virtue of Republic Act No. 4850 as amended by Presidential Decree (P.D) No. 813, and Executive Order (EO) 927, s. 1983, and an attached agency of the DENR with office address at National Ecology Center, East Avenue, Diliman, Quezon City, represented herein by the General Manager, Jaime C. Medina;

WHEREAS, the LLDA is mandated "to promote and accelerate the development and balance growth of the Laguna Lake area and the surrounding provinces, cities and towns within the region, in the context of the national and regional plans and policies for social and economic development and to carry out the development of the Laguna Lake region with due regard and adequate provisions for environment management and control, preservation of the quality of human life and ecological systems, and the prevention of undue ecological disturbances deterioration and pollution";

WHEREAS, the City of Muntinlupa has been chosen again by the LLDA as a recipient and target location for the implementation of the abovementioned project through the provision of ten (10) units of the solar powered paddle wheel;

WHEREAS, blue-green algae have massively proliferated and has caused problem in the natural lake ecosystem balance, the contaminants/nutrients rich substances are fast spreading aquatic mats that have been plaguing the shoreline communities located in the West Bay of Laguna Lake such as Muntinlupa City;

WHEREAS, the decaying algae exudes nauseating putrid odor and causes oxygen depletion and turbidity in the water thereby resulting to fish kill and contamination of drinking water facilities;

WHEREAS, City Government of Muntinlupa and the Laguna Lake Development Authority (LLDA) recognizing the value of uniting and working together to provide a clean, healthy and safe environment, acknowledge and agree to support the environmental improvement of the Laguna Lake, and its tributaries, in accordance of the Memorandum of Understanding (MOU);

WHEREAS, the Laguna Lake Development Authority (LLDA) under the Memorandum of Agreement, shall release funds to the City Government of Muntinlupa for the implementation of "Introduction of Nutrient-Limiting Mechanisms to Prevent Algal Bloom in Laguna Lake";

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa to sign and enter into a Memorandum of Understanding (MOU) with the Laguna Lake Development Authority. (LLDA) represented by General Manager Jaime C. Medina on the provision of ten (10) units solar powered paddle wheel for the Implementation of the project "Introduction of Nutrient Limiting Mechanisms to Prevent Algal Bloom In Laguna Lake".
