**WHEREAS**, Presidential Decree 491 of 1974 or the Nutrition Act of the Philippines created the National Nutrition Council (NNC) to supervise, coordinate and evaluate the implementation of the national nutrition program which shall be implemented by all agencies and instrumentalities of both the government and the private sector;

**WHEREAS**, Republic Act 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Panlungsod to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants;

**WHEREAS**, the *Muntinlupa City Nutrition Committee* is tasked to formulate, revise/update local nutrition plan to include programs, projects and activities that converge in families of the nutritionally vulnerable individuals prepared a Nutrition Action Plan for CY2021 with the end view to significantly reduce the burden of preventable diet related non communicable diseases, obesity and all other forms of malnutrition;
