WHEREAS, Section 455 (b)(1) Xvi) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance";

WHEREAS, Section 35 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "**Linkages with People's Organization and Non-Governmental Organizations – Local Government Units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.**";

WHEREAS, Mother Elisabetta Longhi Foundation, Inc., is a non-profit organization, operating the **Teresa Orsini Home**, an elderly home for the poor, indigent, abandoned and neglected senior citizens. The institution is organized and continued to exist under and by virtue of the Philippine Laws, with Office address located at Don Pedro Reyes Avenue, Victoria Homes Subdivision, Barangay Tunasan, Muntinlupa City;

WHEREAS, the *Mother Elisabetta Longhi Foundation, Inc.*, under Teresa Orsini Home, cooperates with the City Government of Muntinlupa in promoting human rights to the poor, indigent, abandoned and neglected senior Filipino citizens;

WHEREAS, Pursuant to the mandate of the foundation of improving the quality of life for indigent and abandoned senior citizens through its continuous support to maintain the standard quality care, the institution has expressed willingness to cooperate and partner with the City Government of Muntinlupa to promote quality of life to the poor, indigent, abandoned, and neglected senior citizens found/residing in Muntinlupa;

WHEREAS, the *Teresa Orsini Home* shall undertake the selection process of the recommended Senior Citizens in adherence to its policies and guidelines in admittance and selection for this purpose:

- a. **Ensure that the Seniors are duly regarded for their spiritual and corporal needs.**
- b. **As far as practicable, accommodate the indigent and abandoned seniors duly assessed by social workers**
- c. **Provide daily activities**
- d. **Facilitate medical check-up;**
- e. **Provide comfortable accommodation**
- f. **Assign 24/7 nurse and caregivers to attend daily needs.**
- g. **Ensure a safe and conducive living**
- h. **Provide three nutritional meals with snacks**
- i. **Make possible a graceful aging**
- j. **Facilitate end-of-life service**

WHEREAS, the City Government through its Social Service Department shall:

- 1) **Ensure that the senior has complete requirements for admission.**
- 2) **Recommend to the Teresa Orsini Home a senior that is ambulatory and with no serious conditions.**
- 3) **Provide a comprehensive Social Case Study Report;**
- 4) **Submit documents such as NSO, Senior Citizen ID, Senior Citizen Purchase Booklet upon acceptance.**
- 5) **Facilitate family reintegration as much possible.**
- 6) **Support the client's medical needs such as medicines and routine laboratory test (at least twice a year/or as needed)**
- 7) **Provide toiletries such a shampoo and soap at least once a month.**
- 8) **Provides diapers when needed.**
- 9) **Assist end-of-life service.**

WHEREAS, the duration of this MOA is one year and renewable every year.

WHEREAS, the City Legal Office has no objection to the Memorandum of Agreement (MOA);






