A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH D.L. CERVANTES CONSTRUCTION CORPORATION FOR THE PROJECT SITE DEVELOPMENT OF NEW MUNTINLUPA CITY PUBLIC MARKET LOCATED AT BARANGAY ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF FIFTY MILLION SIX HUNDRED SIXTY-THREE THOUSAND FOURTEEN PESOS AND 36/100 (PHP50,663,014.36) WHICH AMOUNT SHALL BE TAKEN FROM 2021 EXECUTIVE BUDGET AND <u>2022</u> EXECUTIVE BUDGET UNDER INFRA FUND AND 20% COMMUNITY DEVELOPMENT FUND (CDF)

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project construction of *Site Development of New Muntinlupa City Public Market located at Barangay Alabang, Muntinlupa City* in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;



WHEREAS, the project was awarded to D.L. Cervantes Construction Corporation who being the lone bidder for the project construction of Site Development of New Muntinlupa City Public Market located at Barangay Alabang, Muntinlupa City;
