Contract Agreement

THIS AGREEMENT, is made this ___day of __2 8 2027 _____, 2022 between the CITY GOVERNMENT OF MUNTINLUPA (hereinafter, the "Entity"), with address at City Hall, National Road, Putatan, Muntinlupa City, and MEGAFIXTURES INC. (hereinafter, the "Supplier"), with address in Quezon City.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz. **Supply & Delivery of Various ICT Equipment for use of Various Offices** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of total amount of **Four Million Five Hundred Sixty-Two Thousand Three Hundred Sixty Pesos (P4,562,360.00)** hereinafter, the ("Contract Price").
