WHEREAS, the vision of Muntinlupa states that, *"drawing inspiration and guidance from God, in perfect harmony with nature and active partnership with all the sectors, we envision Muntinlupa to be a leading investment and business center in the Philippines"*

WHEREAS, Article II, Section 20 of the 1987 Constitution provides that, *the state recognizes the indispensable role of the private sector, encourages private enterprise and provides incentives to needed investments*";

WHEREAS, in pursuit of this goal, the **Fresnedi Administration** thru its responsive governance, effective business and economic policies, the City has earned the distinction of being the most business-friendly local government unit as recognized by the **Philippine Chamber of Commerce and Industry**;

WHEREAS, with the remarkable growth and development of Muntinlupa City, the present leadership has long envisioned this City to be a leading investment and business center in the Philippines by 2020;

WHEREAS, with this vision and upon its realization the socio economic gains resulting from the demands and growth of business and investments in the City would help to uplift the lives of its residents;

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the members of the Sangguniang Panlungsod duly assembled the following:

SECTION 1. The Muntinlupa City Commission on 2020 Vision is hereby created and henceforth shall be referred to in this ordinance as the **"Commission"**.

SECTION 2. Composition. The Muntinlupa City Commission on 2020 Vision shall be composed of the following:

- a) Mayor - as Honorary Chairman
- b) Vice-Mayor - as Honorary Vice-Chairman
- c) Representative from the City Council (Chairman of the Committee on Trade and Industry) - Member
- d) President of the Muntinlupa Chamber of Commerce - Member
- e) Area Director from Alabang Town Center Corporation - Member
- f) Area Director from Filinvest Corporate City Corporation - Member
- g) Area Director from Metropolis Star Corporation - Member
- h) One Representative from existing Civic Groups - Member
- i) FOVA President - Member
- j) One Representatives from the NGOs in Muntinlupa - Member
- k) City Planning Head - Member
- l) Business Permit and License Office Head - Member
- m) Public Employment and Services Office Head - Member
- n) City Police Chief - Member
- o) City Engineer - Member
- p) Head of Secretariat to be appointed by the City Mayor and whose membership is renewable biennially, starting on the day of the creation of the commission.-Member

SECTION 3. A Technical Working Group is hereby created to support the **Commission** in its duties and responsibilities whose members will be appointed by the Honorable City Mayor.

SECTION 4. Duties and functions - The **Muntinlupa City Commission on 2020 Vision** shall have the following duties and functions:

- 1. Define a short-term goal that will graduate and its strategies at the start of every triennial until 2020.
- 2. Consolidate, through the Secretariat, all the developmental plans of the companies and offices the **Commission** represents until 2020.
- 3. Define strategies, landmarks and other indicators to facilitate the realization of every triennial goal.
- 4. Monitor the implementation of the plans and ensure that the programs and activities of the triennial goals are realized.
- 5. Represent the City in various local and international development for a in consonance with the vision.

6. Lead in the promotion and marketing of the city to pursue local and international investments. (the **Commission** as deemed necessary may opt to hire marketing strategy consultants).
7. Coordinate with local and international funding agencies for possible financial and technical support for the programs of every triennial goal.
8. Continuously foster a business friendly environment that promotes good governance and corporate responsibility.
9. The **Commission** shall elect among them the Chairperson and Vice-Chairperson of the **Commission** (and all other positions deemed necessary) at the start of every triennial with the incumbent Mayor and Vice Mayor as honorary Chairperson and Vice Chairperson respectively.
10. The elected Chairperson shall lead in defining the graduating triennial goals with its strategies.

SECTION 5. Meeting and Quorum. The **Commission** shall hold regular meeting at least twice a month or as often as maybe necessary. Any of the co-chairman may call a meeting. A majority of all its members shall constitute a quorum. However, when both co-chairman are present in a meeting the Local Chief Executive concerned as a matter of protocol, shall be given preference to preside over the meeting. The affirmative vote of the majority of all the members shall be necessary to approve any measure to be adopted by the **Commission**.

SECTION 6. Honoraria. The officers and members of the **Commission** may be entitled to an honorarium subject to the availability of funds and discretion of the City Mayor.

SECTION 7. Effectivity. This ordinance shall take effect ten (10) days after posting in the Bulletin Board of the Sangguniang Panlungsod.
