AN ORDINANCE ADOPTING AND GRANTING FINANCIAL ASSISTANCE TO THE LOCAL GOVERNMENT OF DARAGA, PROVINCE OF ALBAY, IN THE AMOUNT OF THREE MILLION PESOS (PHP3,000,000.00) FOR RELIEF ASSISTANCE FOR NEARBY AFFECTED MUNICIPALITIES BROUGHT ABOUT BY MAYON VOLCANO EXPLOSION WHICH AMOUNT SHALL BE TAKEN FROM THE 2018 EXECUTIVE BUDGET UNDER 5% MUNTINLUPA CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND (MCDRRMF).

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panlungsod of Muntinlupa, to adopt and grant financial assistance to the Local Government of **Municipality of Daraga, Province of Albay**, in the amount of **Three Million Pesos (Php3,000,000.00)** for the relief assistance for nearby affected Municipalities brought about by Mayon Volcano Eruption/Explosion which amount shall be taken from the 2017 Executive Budget under 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF).

RESOLVED FURTHER, that the Local Government of Daraga, Province of Albay, shall prepare all necessary documents to process the financial assistance grant by the City Government of Muntinlupa.




