WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances":

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, it is the policy of the City Government to provide support to its constituents especially in the aspect of sustainable growth and development through self-reliance and productive programs;

WHEREAS, the City Cooperative Office, thru Herminio A. Dela Cruz, endorsed and recommended to the City Council the loan application of Pag-Asa Sa Paglaya Multi-Purpose Cooperative, in the amount of One Million Pesos (Php1,000,000.00) dated May 17, 2017;

WHEREAS, the Pag-Asa Sa Paglaya Multi-Purpose Cooperative, has requested the City Government of Muntinlupa for a loan assistance in the amount of One Million Pesos (Php1,000,000.00) to be taken from the 2018 Executive Budget under Cooperative Fund:

**WHEREAS**, there is an available Budget from the 2018 Executive Budget of the City under the Cooperative Office;

NOW THEREFORE, ORDAIN, AS IT IS HEREBY ORDAINED, by the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to grant the loan assistance to *Pag-Asa Sa Paglaya Multi-Purpose Cooperative*, in the amount of **One Million Pesos** (Php1,000,000.00) to be taken from 2018 Executive Budget under Cooperative Fund of the City and authorizing the *City Mayor, Hon. **RESOLVED FURTHER**, that a Certificate of Availability of Fund and Certificate of Fund Allotment shall be issued by the Office of the City Treasurer and City Budget, respectively.
