## ORDINANCE NO. 18-173

AN ORDINANCE GRANTING TEN THOUSAND PESOS (PHP10,000.00) TO EVERY HOUSEOWNER (TOTALLY DAMAGED) THREE THOUSAND PESOS (PHP3,000.00) TO HOUSE OWNER (PARTIALLY DAMAGED) FIVE THOUSAND PESOS (PHP5,000.00) TO EVERY HOUSE RENTERS AND SHARERS (TOTALLY DAMAGED), AND OTHER ASSISTANCE TO THE AFFECTED BY THE FIRE ON JUNE 4, 2018, IN ESPELETA PANTALAN, BARANGAY POBLACION, MUNTINLUPA CITY, WHICH AMOUNT SHALL BE TAKEN FROM THE 2018 EXECUTIVE BUDGET UNDER 5% MUNTINLUPA CITY RISK REDUCTION DISASTER AND MANAGEMENT FUND (MCRRDMF).

WHEREAS, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall":

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on 11<sup>TH</sup> day of June 2018, on its 75<sup>th</sup> Regular Session, the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, approved Resolution No. 18-314, "declaring the area affected by the fire on June 4, 2018 in Espeleta Pantalan, Barangay Poblacion, Muntinlupa City, as in a state of calamity".

WHEREAS, on June 4, 2018 in Espeleta Pantalan, Barangay Poblacion, *Muntinlupa City* a fire totally destroyed *Two Hundred Ten (210)* House/Structures and displaced *Three Hundred Ten (310) families* as per attached final report of Social Welfare and Development Office (SWDO) which shall form part of this Ordinance;

**WHEREAS**, the owner of the houses and renters, were rendered homeless by reason of the said conflagration;

WHEREAS, the City Government shall also give other assistance for the immediate needs of the affected families;

WHEREAS, the Social Welfare and Development Office (SWDO) of the City has submitted a certified copy of the list of the homeowners and renters (totally damaged and partially damaged) in coordination with the Barangay Chairman of Poblacion, Hon. Allen F. Ampaya is made an integral part of this ordinance and shall be known as ANNEX A;

WHEREAS, there is an available fund from the 2018 Executive Budget under 5% Muntinlupa Disaster Risk Reduction and Management Fund (LDRRMF);

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 8<sup>th</sup> Sangguniang Panlungsod, to grant Ten Thousand Pesos (Php10,000.00) to every house owner (Totally Damaged) Three Thousand Pesos (Php3,000.00) to house owner (Partially Damaged) Five Thousand Pesos (Php5,000.00) to every house renters and sharers (Totally Damaged), and other assistance to the families affected by the fire on June 4, 2018, in Espeleta Pantalan, Barangay Poblacion, Muntinlupa City which amount shall be taken from the 2018 Executive Budget under 5% Muntinlupa City Risk Reduction Disaster and Management Fund (MCRRDMF).

ENACTED, by the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, this 11<sup>th</sup> of June 2018, on its 75<sup>th</sup> Regular Session.
