ORDINANCE NO. 18-177

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO SIX (6) AFFECTED FAMILIES SUBMITTED BY THE URBAN POOR AFFAIRS OFFICE (UPAO) AMOUNTING TO FIVE THOUSAND PESOS (PHP5,000.00) EACH OR A TOTAL AMOUNT OF THIRTY THOUSAND PESOS (PHP30,000.00) WHO WERE AFFECTED BY DEMOLITION OF STRUCTURES BY THE SPECIAL TASK FORCE ON SQUATTING PREVENTION (STFSP) ALONG PNR SITE LAGUERTA, BARANGAY TUNASAN, MUNTINLUPA CITY ON OCTOBER 16-17, 2016 AND MARCH 16, 2018 WHICH AMOUNT SHALL BE TAKEN FROM 2018 EXECUTIVE BUDGET SOCIALIZED HOUSING, LAND BANKING, COMMUNITY MORTGAGED PROGRAM AND OTHER RELATED ACTIVITIES UNDER THE NON-OFFICE MOOE.

WHEREAS, on October 16-17, 2016 and **March 16, 2018**, the **Special Task Force On Squatting Prevention (STFSP)** demolished the structure along PNR Site, Laguerta, Barangay Tunasan, Muntinlupa City;

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, adopt resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx and shall";

WHEREAS, on April 16, 2018, Ms. Alita A. Ramirez OIC, Urban Poor Affairs Office (UPAO) wrote a letter to the Hon. City Mayor, Atty. Jaime R. Fresnedi requesting to grant financial assistance to six (6) families;

WHEREAS, the structure of the six (6) families were demolished due to the on-going infrastructure projects of the Department of Public Works and Highways (DPWH);

WHEREAS, the Urban Poor Affairs Office (UPAO) recommended to grant financial assistance for the affected individuals by the said demolition by the Special Task Force on Squatting Prevention;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the 8th Sangguniang Panlungsod duly assembled to grant financial assistance to Six (6) affected individuals submitted by the Urban Poor Affairs Office (UPAO) amounting to **Five Thousand Pesos (Php5,000.00)** each or a total amount of **Thirty Thousand Pesos (Php30,000.00)** Who Were Affected By Demolition Of Structures By The Special Task Force On Squatting Prevention (STFSP) Along PNR Site, Laguerta, Barangay Tunasan, Muntinlupa City on **October 16-17, 2016 and March 16, 2018** which amount shall be taken from **2018 Executive Budget Socialized Housing, Land Banking, Community Mortgaged Program and Other Related Activities Under The Non-Office MOOE.**
