ORDINANCE NO. 18-190

AN ORDINANCE PROVIDING SCHOLARSHIP GRANTS TO STUDENTS OF MARAWI CITY THROUGH THE LOCAL GOVERNMENT OF CITY OF MARAWI, LANA DEL SUR, IN THE AMOUNT OF FIVE MILLION PESOS (PHP5,000,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2018 EXECUTIVE BUDGET UNDER THE MUNTINLUPA SCHOLARSHIP PROGRAM (MSP) AND SHALL BE BUDGETED ANNUALLY UP TO FIVE (5) YEARS.

WHEREAS, Article XIV, Section 1 of the 1987 Philippine Constitution, *“provides for the protection and promotion of the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all”*;

WHEREAS, in the afternoon of 23 May 2017, an armed conflict between the government troops and Maute Group transpired in *Barangay Basak Malutlut, Marawi City*;

WHEREAS, the clash affected and displaced, 45,109 families of 215,434 persons of which 3,822 families^a or 18,472 persons who stayed in 33 evacuation centers including schools and learning centers and 41,287 families or 196,961 persons stayed with either their relatives or friends;

WHEREAS, the Department of Education (DepEd) declares around 22,000 students and 2,205 teachers were among those who were affected by the Marawi Siege;

WHEREAS, there are also more than 2,000 displaced students from Marawi City who are accommodated by public schools in and outside of Mindanao;

Ordinance No. 18-190

WHEREAS, for humanitarian response to fill-in the critical gaps and provide for the educational needs of the displaced students, to enable them to recover from the strife-torn situation, and to uplift their living condition, the City Government of Muntinlupa, through the Muntinlupa Scholarship Program, is extending scholarship grants amounting to **Five Million Pesos (Php5,000,000.00)** for the students of Marawi City, most particularly the poorest of the poor;

WHEREAS, on May 27, 2018 the Sangguniang Panlungsod of the Islamic City of Marawi enacted an Ordinance Providing funds for Marawi Scholarship Program to Elementary, Secondary and College students who are Internally Displaced Persons (IDPS) in the amount of Ten Million Pesos (Php10,000,000.00) including the (Five Million Pesos (Php5,000,000.00) scholarship grant from the City Government of Muntinlupa) which was been allocated for the purpose;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by 8th Sangguniang Panlungsod of Muntinlupa in Session assembled that:

SECTION 1. Title – This ordinance shall be known as, “*An Ordinance Providing Scholarship Grants To Students Of Marawi City Through The Local Government Of City Of Marawi, Lanao Del Sur, In The Amount Of Five Million Pesos (Php5,000,000.00) Which Amount Shall Be Taken From The 2018 Executive Budget Under The Muntinlupa Scholarship Program (MSP) Fund And Every Year Thereafter For Five Years.*”

SECTION 2. Appropriation – the amount of Five Million Pesos (Php5,000,000.00) shall be allocated in the Annual Budget of the City starting 2018. The same amount shall likewise be allotted/appropriated in the Annual Executive Budget until the end of the fifth year period (2023) of the Scholarship grant. From this purpose, the Muntinlupa Scholarship Program is directed to include in its annual investment program the same grant and budget.

SECTION 3. The said amount shall be released in lump sum to the Local Government of the City of Marawi, in coordination with the City of Muntinlupa for Muslim Affairs, for the benefit of the **Internally Displaced Persons (IDPS) of Marawi City** which may be distributed to qualified and deserving students on a quarterly basis subject to the rules and regulations that may be promulgated by the City Government of Marawi.

SECTION 4. The City Government of Marawi shall provide the City Government of Muntinlupa with a detailed report including utilization report on the subject scholarship grants to include a detailed list of student beneficiaries to be updated from time to time.

ENACTED, by the 8th *Sangguniang Panlungsod of Muntinlupa*, this 13th day of August, 2018, on its 84th **Regular Session**.


