ORDINANCE NO. 18-195

AN ORDINANCE GRANTING TEN THOUSAND PESOS (PHP10,000.00) TO EVERY HOUSEOWNER (TOTALLY DAMAGED) THREE THOUSAND PESOS (PHP3,000.00) TO HOUSE OWNER (PARTIALLY DAMAGED) FIVE THOUSAND PESOS (PHP5,000.00) TO EVERY HOUSE RENTERS AND SHARERS (TOTALLY DAMAGED), AND OTHER ASSISTANCE TO THE FAMILIES AFFECTED BY THE FIRE ON AUGUST 25, 2018, AT #309 UMALI STREET, UMALI COMPOUND, BARANGAY POBLACION, MUNTINLUPA CITY, WHICH AMOUNT SHALL BE TAKEN FROM THE 2018 EXECUTIVE BUDGET UNDER 5% MUNTINLUPA CITY RISK REDUCTION DISASTER AND MANAGEMENT FUND (MCRDDMF).

WHEREAS, Section 458 (a)(l)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall":

(l)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on 10th day of September 2018, on its 88th Regular Session, the 8th Sangguniang Panlungsod of Muntinlupa, approved Resolution No. 18-354, "declaring the area affected by the fire on August 25, 2018 in #309 Umali Street, Umali Compound, Barangay Poblacion, Muntinlupa City, as in a state of calamity".

WHEREAS, on August 25, 2018, at #309 Umali Street, Umali Compound, Barangay Poblacion, Muntinlupa City respectively, a fire totally destroyed four (3) House/Structures and five (5) families/24 individuals as per attached final report of Social Welfare and Development Office (SWDO) which shall form part of this Ordinance;

WHEREAS, the owner of the houses and renters, were rendered homeless by reason of the said conflagration;

WHEREAS, the City Government shall also give other assistance for the immediate needs of the affected families;

WHEREAS, the **Social Welfare and Development Office (SWDO)** of the City has submitted a certified copy of the list of the homeowners and renters (totally damaged and partially damaged) in coordination with the **Barangay Chairman of Poblacion, Hon. Allen F. Ampaya** is made an integral part of this ordinance and shall be known as **ANNEX A**;

WHEREAS, there is an available fund from the **2018 Executive Budget** under **5% Muntinlupa Disaster Risk Reduction and Management Fund (LDRRMF)**;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 8th **Sangguniang Panlungsod**, to grant Ten Thousand Pesos (Php10,000.00) to every house owner (Totally Damaged) Three Thousand Pesos (Php3,000.00) to house owner (Partially Damaged) Five Thousand Pesos (Php5,000.00) to every house renters and sharers (Totally Damaged), and other assistance to the families affected by the fire on **August 25, 2018, in #309 Umali Street, Umali Compound, Barangay Poblacion, Muntinlupa City**, which amount shall be taken from the 2018 Executive Budget under **5% Muntinlupa City Risk Reduction Disaster and Management Fund (MCRDDMF)**.

ENACTED, by the 8th **Sangguniang Panlungsod of Muntinlupa**, this 10th day of **September 2018**, on its 88th Regular Session.


