## ORDINANCE NO. 18-218

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE AMOUNTING TO TEN THOUSAND PESOS (PHP10,000.00) EACH TO NINETY (90) FAMILIES WHO VOLUNTEERED TO BE RELOCATED AND TRANSFERRED TO VILLA STA. ROSA AND DON JOSE HOMES, CALAMBA, LAGUNA UNDER THE PROGRAM/PROJECT OF THE NATIONAL GOVERNMENT OPLAN LIKAS WITH A TOTAL AMOUNT OF NINE HUNDRED THOUSAND PESOS (PHP900,000.00) WHICH AMOUNT SHALL BE TAKEN FROM 2018 EXECUTIVE BUDGET SOCIALIZED HOUSING, LANDBANKING, COMMUNITY MORTGAGED PROGRAM AND OTHER RELATED ACTIVITIES UNDER THE NON-OFFICE MOOE.

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, adopt resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx and shall";

WHEREAS, the Urban Poor Affairs Office (UPAO) requested the grant of financial assistance to the ninety (90) relocated volunteer families which were transferred to Villa Sta. Rosa and Don Jose Homes, Calamba, Laguna under the Oplan LIKAS (Lumikas para Iwas Kalamidad at Sakit) program of the national government;

**WHEREAS**, there is a need for the City Government to give financial assistance to the aforesaid individuals;

WHEREAS, there is *no legal impediment* on the granting of financial assistance to the affected families since it has undergone to the proper screening, documentation, demolition procedures and has allocated budget/funds for the purpose;

WHEREAS, as certified by the Budget Office that there is an available fund from the 2018 Executive Budget under the Socialized Housing, Land Banking, Community Mortgaged Program and Other Related Activities under the Non-Office MOOE;
