AN ORDINANCE GRANTING THIRTY THOUSAND SEVEN HUNDRED TWENTY PESOS (PHP30,720.00) EACH OR A TOTAL AMOUNT OF ONE HUNDRED TWENTY TWO THOUSAND EIGHT HUNDRED EIGHTY PESOS (PHP122,880.00) TO FOUR (4) FAMILIES AFFECTED BY VIRTUE OF A WRIT OF DEMOLITION FACILITATED BY REGIONAL TRIAL COURT BRANCH 110 LAST JULY 19, 2018, IN THE PROPERTY OWNED BY SPOUSES ALFREDO HEREDIA AND AURORA HEREDIA LOCATED AT GOD'S WILL 2, BARANGAY PUTATAN, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM 2018 EXECUTIVE BUDGET SOCIALIZED HOUSING, LAND BANKING, COMMUNITY MORTGAGED PROGRAM AND OTHER RELATED ACTIVITIES UNDER THE NON-OFFICE -MOOE.

WHEREAS, the stated appeared in the list of potential socialized housing beneficiaries of the Urban Development and Housing (UDHA). Based on Sec. 28, Article VII of UDHA beneficiary of this act is entitled for a relocation or financial assistance in the amount equivalent to the prevailing minimum daily wage multiplied by sixty (60) days;

WHEREAS, in compliance with the law, each beneficiary is entitled for an amount of Thirty Thousand Seven Hundred Twenty Pesos (Php30,720.00) each or a total of One Hundred Twenty Two Thousand Eight Hundred Eighty Pesos (Php122,880.00) for the four (4) beneficiaries;

WHEREAS, the Legal Office has **no legal impediment** on the grant of financial assistance to the affected families since it has undergone to the proper screening, documentation, demolition procedures and has allocated budget/funds for the purpose;
