ORDINANCE NO. 19-232

AN ORDINANCE GRANTING FINANCIAL AND RELIEF ASSISTANCE TO THE MUNICIPALITIES OF BUHI, SAGÑAY, BULA, BATO, AND NABUA, PROVINCE OF CAMARINES SUR WHICH WERE DEVASTED BY TYPHOON USMAN AMOUNTING TO THREE MILLION FIVE HUNDRED THOUSAND PESOS (Php3,500,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2019 EXECUTIVE BUDGET UNDER THE 5% MUNTINLUPA CITY DISASTER AND RISK REDUCTION MANAGEMENT FUND (MCDRRMF).

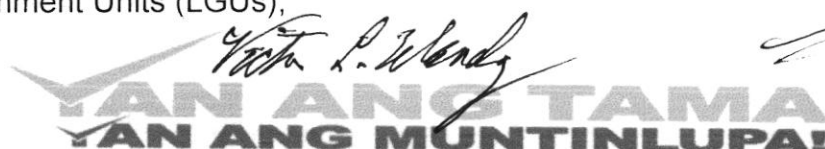

WHEAREAS, Rule 18, Section 2, of the Implementing Rules and Regulations of Republic Act No. 10121, provides that, "**for a Quick Response Fund (QRF) intends for "relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disaster calamities, epidemics, or complex emergencies, may be normalized as quickly as possible";**

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 or An Act amending Section 324(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates that, "**a portion of Calamity Fund may be authorized to be used by the Local Government Unit (LGU) concerned to provide financial assistance to other Local Government Units (LGUs);**

WHEREAS, the Municipalities of **Buhi, Sagñay, Bula, Bato, And Nabua, Province Of Camarines Sur** were hit by typhoon Usman which claimed lives and suffered damages to properties;

WHEREAS, through a letter-request and resolutions from their respective Councils, the **Municipalities of Buhi, Sagñay, Bula, Bato, And Nabua, Province Of Camarines Sur.** Appealed to the City Mayor Atty. Jaime R. Fresnedi and the City Government of Muntinlupa for a financial and relief assistance to aid in the recovery and rehabilitation of their respective Local Government Units (LGUs);

WHEREAS, there is an available fund from the **2019 Executive Budget under the 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)** of the City Government of Muntinlupa;

WHEREAS, through a Muntinlupa City Disaster and Risk Reduction and Management Council (MCDRRMC) Resolution No. 2019-001 the financial aid amounting to **Three Million Five Hundred Thousand Pesos (Php3,500,000.00)** will be distributed as follows:

MUNICIPALITIES	AMOUNT
1) Buhi	Php1,000,000.00
2) Sagñay	Php1,000,000.00
3) Bula	Php 500,000.00
4) Bato	Php 500,000.00
5) Nabu	Php 500,000.00

WHEREAS, the law requires that the grant of assistance to the above-named Local Government Units (LGUs) is subject to the **Post-Damage Assessment Need Analysis (PDANA)** by the donor-city which is the City of Muntinlupa;

NOW THEREFOR, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the **8th Sangguniang Panglungsod of Muntinlupa**, to grant financial and relief assistance to the **Municipalities of Buhi, Sagñay, Bula, Bato, And Nabua, Province Of Camarines Sur** which were devastated by **Typhoon Usman** amounting to **Three Million Five Hundred Thousand Pesos (Php3,500,000.00)** which amount shall be taken from the **2019 Executive Budget** under the **5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)**.

ENACTED, by **8th Sangguniang Panlungsod of Muntinlupa**, this **14th** day of **January 2019**, on its **100th Regular Session**.


