WHEREAS, in response to said advertisements and/or postings, one bidder submitted sealed bid on or before the deadline last January 17, 2019 which sealed bid was then opened on the same day January 17, 2019;

WHEREAS, the Members of the Bids and Awards Committee (BAC) and the Technical Working Group hereby recommends the award, based on the foregoing findings, to *Leonel Waste Management Corporation* for approval of the Hon. City Mayor Atty. Jaime R. Fresnedi;

WHEREAS, there is an available fund from the 2019 Executive Budget as certified by the Budget Officer;

WHEREAS, in the public bidding that was conducted by the Bids and Awards Committee (BAC) the bid proposal by the Leonel Waste Management Corporation was found to be the Lowest Calculated and Responsive Bid (LCRB) for which a Notice of Award has been issued by the City Mayor;

WHEREAS, the Approved Budget for the Contract (ABC) amounting to Two Hundred Forty Million Two Hundred Forty Thousand Pesos (Php240,240,000.00);

WHEREAS, the bidding as per documents submitted to the City Council and declaration of the representatives of the members of the BAC, the bidding process complied with Republic Act No. 9184 and other pertinent rules and regulations, laws;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8th Sangguniang Panlungsod of Muntinlupa, authorizing the Hon. City Mayor Atty. Jaime R. Fresnedi to enter into and sign the contract in behalf of the City Government of Muntinlupa with Leonel Waste Management Corporation for the garbage collection and disposal services from April 1, 2019 to December 31, 2019 amounting to One Hundred Eighty Million One Hundred Sixty Two Thousand Pesos (Php180,162,000.00) which amount shall be taken from the 2019 Executive Budget.

RESOLVED FURTHER, that Leonel Waste Management Corporation is mandated to institute and strictly implement the health and safety of its employees (paleros) by provision of safety gears in the conduct of collection of garbage/waste products;
