A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH JOINT VENTURE OF JANDEC CONSTRUCTION BUILDERS & STARCROSS CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF HIGH SCHOOL BUILDING LOCATED AT MNHS ANNEX, SOUTHVILLE 3, BARANGAY POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF THIRTY EIGHT MILLION TWO HUNDRED NINE THOUSAND FIFTY PESOS AND 26/100 (PHP38,209,050.26) WHICH AMOUNT SHALL BE TAKEN FROM THE 2018 SCHOOL BOARD FUND UNDER SPECIAL EDUCATION FUND (SEF).




