FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONTRACT OF SERVICE WITH MAHALIMUYAK LAUNDRY CORP., FOR THE SUPPLY AND DELIVERY OF LAUNDRY SERVICES AT THE OSPITAL NG MUNTINLUPA FROM APRIL 1 TO DECEMBER 31, 2019 IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED FIFTY SIX THOUSAND TWO HUNDRED FIFTY PESOS (PHP1,856,250.00) WHICH AMOUNT SHALL BE TAKEN FROM 2019 EXECUTIVE BUDGET.

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid for the project a Contract of Service with *Mahalimuyak Laundry Corp., for the supply and delivery of* Laundry Services at the Ospital ng Muntinlupa in a newspaper of general circulation, likewise, posted at the Government Electronic Procurement System (GEPS) and City's Website and the same in conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) bidder submitted letter of intent and application for eligibility and was found eligible on **January 17, 2019**;
