A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH JADOMINA CONSTRUCTION AND SUPPLIES FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE LOCATED AT GAWAD KALINGA, SOLDIERS HILLS, BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF FOUR MILLION THIRTY FIVE THOUSAND THREE HUNDRED FORTY SIX PESOS (PHP4,035,346.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2019 EXECUTIVE BUDGET UNDER INFRASTRUCTURE FUND.

WHEREAS, pursuant to Section 76 of RA. 9184 states that, “**any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly**”;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project **Construction Of Multi-Purpose Located At Gawad Kalinga, Soldiers Hills, Barangay Putatan, Muntinlupa City** in a newspaper of general circulation, posted at the Government Electronic Procurement System (GEPS) and City’s Website and likewise, posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) bidders submitted letter of intent and application for eligibility, and was found eligible on March 12, 2019, ;


