A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONTRACT OF SERVICE WITH BEST SECURITY AGENCY FOR THE SECURITY AND PROTECTION TO SCHOOL DIVISION OFFICE LOCATED AT LAGUERTA, BARANGAY TUNASAN, MUNTINLUPA CITY FROM APRIL 1 TO DECEMBER 31, 2019 IN THE AMOUNT OF TWENTY SEVEN MILLION NINE HUNDRED TWENTY TWO THOUSAND NINE HUNDRED FOURTEEN PESOS AND 72/100 (PHP27,922,914.72) WHICH AMOUNT SHALL BE TAKEN FROM 2019 EXECUTIVE BUDGET UNDER THE GENERAL FUND.

**WHEREAS**, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid for the services **security and protection to School Division Office located at Laguerta, Barangay Tunasan, Muntinlupa City** in a newspaper of general circulation, likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same in conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in view of the expiration of the existing contract for security and protection to **School Division Office located at Laguerta, Barangay Tunasan, Muntinlupa City** has caused the procurement of the said Contract for 2019 through open and competitive bidding, in accordance with the provisions of Republic Act No. 9184 or the Government Procurement Reform Act;

**WHEREAS**, the project was awarded to **Best Security Agency** who being the lowest bidder for the **security and protection to School Division Office located at Laguerta, Barangay Tunasan, Muntinlupa City**;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 8<sup>TH</sup> **Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Contract of Service with Best Security Agency for the security and protection to School Division Office located at Laguerta, Barangay Tunasan, Muntinlupa City from **April 1 to December 31, 2019** in the amount of **Twenty Seven Million Nine Hundred Twenty Two Thousand Nine Hundred Fourteen Pesos and 72/100 (Php27,922,914.72)** which amount shall be taken from 2019 Executive Budget Under The General Fund.


