WHEREAS, the Department of Education, issued DepEd Order No.016 s. 2019, dates 12 July 2019, which pertains to the "Amendment to DECS Order No.7, s.1999 (Policies on Selection/Appointment and Transfer/Reassignment of DECS Regional Officials);

WHEREAS, in the said DepEd Order No. 016, a new paragraph is introduced, to read as follows: "There shall be simultaneous transfer/reassignment of Regional Directors (RDs), Assistant Regional Directors (ARDs), Schools Division Superintendents (SDSs), and Assistant Schools Division Superintendents (ARDSs) once every three(3) years.";

WHEREAS, the simultaneous transfer/reassignment for all ARDs and SDSs shall be implemented in July 2019;

WHEREAS, the Honorable City Mayor, Jaime R. Fresnedi, has written His Excellency, President Rodrigo R. Duterte, through Honorable Secretary Leonor M. Briones, Ph.D., dated July 25, 2018, requesting for the retention of Dr. Mauro C. De Gulan as Schools Division Superintendent of Muntinlupa City;

WHEREAS, the Chief Executive stressed in his letter that the "City Government of Muntinlupa, in partnership with the Schools Division Office of Muntinlupa, has been consistent in raising the bar of education in the city through various continuous improvement programs, which significantly target the holistic development of our dear learners in the 28 different schools";




