AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 19-245, ENTITLED, "AN ORDINANCE CREATING THE REGULAR POSITIONS AT MUNTINLUPA CITY PERSONS WITH DISABILITY AFFAIRS OFFICE (MC-PDAO) AND AMENDING SECTION 5 OF ORDINANCE NO. 18-167, ENTITLED, "AN ORDINANCE ORGANIZING AND ESTABLISHING THE MUNTINLUPA CITY PERSONS WITH DISABILITY AFFAIRS OFFICE (MC-PDAO) IN ACCORDANCE WITH SECTION 40(B)(1) OF REPUBLIC ACT NO. 7277, OTHERWISE KNOWN AS THE "MAGNA CARTA FOR PERSONS WITH DISABILITY, AS AMENDED BY REPUBLIC ACT NO. 9442 AND REPUBLIC ACT NO. 10070."

WHEREAS, on March 11, 2019, the 8th Sangguniang Panlungsod enacted Ordinance No. 19-245, otherwise known as "An Ordinance Creating The Regular Positions At Muntinlupa City Persons With Disability Affairs Office (MC-PDAO) and amending Section 5 of Ordinance No. 18-167, entitled, "An ordinance organizing and establishing the Muntinlupa City Persons With Disability Affairs Office (MC-PDAO) in accordance with Section 40(B)(1) of Republic Act No. 7277, otherwise known as the "Magna Carta for Persons With Disability, as amended by Republic Act No. 9442 and Republic Act No. 10070.";

WHEREAS, Republic Act No. 10070. Rule V, Head of PDAO and Focal Person, Section 7, states that, "Priority shall be given to qualified person with disabilities in the appointment of the head of PDAO for the xxx, cities xxx";

WHEREAS, representative of City Human Resources Management and Development Office recommended to amend Ordinance No. 19-245 by virtue of Republic Act No. 10070. Rule V, Head of PDAO and Focal Person, Section 7, states that, "Priority shall be given to qualified person with disabilities in the appointment of the head of PDAO for the xxx, cities xxx".

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 9th Sangguniang Panlungsod of Muntinlupa, in session assembled that:

SECTION 1. Title – This ordinance shall be known as An Ordinance Amending Section 2 Of Ordinance No. 19-245, Entitled, “An Ordinance Creating The Regular Positions At Muntinlupa City Persons With Disability Affairs Office (Mc-Pdao) And Amending Section 5 Of Ordinance No. 18-167, Entitled, “An Ordinance Organizing And Establishing The Muntinlupa City Persons With Disability Affairs Office (Mc-Pdao) In Accordance With Section 40(B)(1) Of Republic Act No. 7277, Otherwise Known As The “Magna Carta For Persons With Disability, As Amended By Republic Act No. 9442 And Republic Act No. 10070.”

SECTION 2. Section 2, paragraph 1 of Ordinance No. 19-245 read as follows:

The **Disability Affairs Officer IV** shall head the MC-PDAO and shall be a PWD, in compliance of Section 15 of the Republic Act 10070. Further at least half of the MC-PDAO and shall be a PWD. Further at least half of the MC-PDAO personnel, including the Head shall be, as far as practicable, PWDs.

SHALL NOW BE READ AS FOLLOWS

“The **Disability Affairs Officer IV**, who is *not necessarily a Person with Disability*, shall Head of **Muntinlupa City-Persons with Disability Affairs Office (MC-PDAO)** provided that he/she has met all the minimum qualifications standard set forth by Republic Act No. 10070. However, priority in the appointment of Head of **Persons with Disability Affairs Office (PDAO)** shall be given to **Persons with Disability (PWD)** who have applied and qualified to the position. Further, at least half of the **Muntinlupa City Persons with Disability Affairs Office (MC-PDAO)** and shall be a **Persons with Disability (PWD)**. Further at least half of the **Muntinlupa City Persons with Disability Affairs Office (MC-PDAO)** personnel, including the Head shall be, as far as practicable, PWDs.”

SECTION 3. Repealing Clause. All existing ordinances, resolution, local executive orders, rules and regulations inconsistent herewith are hereby repealed and suspended or modified accordingly.

SECTION 4. Separability Clause. Should any provision of this Ordinance be declared unconstitutional or invalid by any court of competent jurisdiction, the provisions not affected in **Ordinance No. 19-245** shall continue to be in full force and effect.

SECTION 5. Effectivity. This Ordinance shall take effect in **January 1, 2020.**

ENACTED, by 9th Sangguniang Panlungsod of Muntinlupa this 14th day of October, 2019, on its 16th Regular Session.
