FRESNEDI, IN BEHALF OF THE OSPITAL NG MUNTINLUPA WITH INTEGRATED WASTE MANAGEMENT FOR THE SUPPLY AND DELIVERY OF COLLECTION, TREATMENT & DISPOSAL OF VARIOUS HOSPITAL WASTES FROM APRIL 1 TO DECEMBER 31, 2019 IN THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (PHP800,000.00) WHICH AMOUNT SHALL BE TAKEN FROM 2019 EXECUTIVE BUDGET.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "**xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others**";

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "**the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

WHEREAS, the City Government of Muntinlupa invited bids for certain goods and ancillary services for collection, Treatment and Disposal of various hospital waste of Ospital ng Muntinlupa (2019), but as a result of two failed biddings, the City Government entered into negotiations and accepted the proposal of the Integrated Waste Management Inc., for the supply of those goods and services in the sum of **Eight Hundred Thousand Pesos (Php8,000.00)** as the contract price;

WHEREAS, in view of two failed biddings, the City Government of Muntinlupa thru the **Bids and Awards Committee (BAC)** posted, at its own website and in a conspicuous place within its premises, an invitation to submit proposals, complete with terms, delivery schedule and technical specifications, for the collection, treatment and disposal of various hospital waste at Ospital ng Muntinlupa with an Approved Budget for the Contract (ABC) of **Eight Hundred Thousand Pesos (Php800,000.00)**;

WHEREAS, in response to said posting, sealed proposals was submitted to the **Bids and Awards Committee (BAC)** on or before the deadline last March 5, 2019;

WHEREAS, the sealed proposal received was then forwarded by the **Bids and Awards Committee (BAC)** to the **Technical Working Groups (TWG)** for its evaluation and recommendation;

WHEREAS, the **Bids and Awards Committee (BAC)** received the favorable recommendation from the **Technical Working Groups (TWG)** for the award of the contract to Integrated Waste Management Inc., a contractor of known technical, legal and financial competence, at the negotiated price of **Eight Hundred Thousand Pesos (Php800,000.00)**;

WHEREAS, the negotiated contract was awarded to **Integrated Waste Management, Inc.**, who being the lone bidder for the collection, treatment and disposal of various hospital waste at Ospital ng Muntinlupa;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9TH **Sangguniang Panlungsod**, to ratify the **Negotiated Contract** entered into by the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the Ospital ng Muntinlupa with **Integrated Waste Management, Inc.**, for the supply and delivery of collection, treatment & disposal of various hospital wastes from **April 1 to December 31, 2019** in the amount of **Eight Hundred Thousand Pesos (Php800,000.00)** which amount shall be taken from 2019 Executive Budget.
