WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, **"xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned"**;

WHEREAS, the Philippine National Police (PNP) is mandated to maintain peace and order and shall take all necessary steps to ensure public safety, including investigation and prevention of crimes;

WHEREAS, in order of the Philippine National Police (PNP) to effectively perform its mandate under existing laws, there is a need to enhance its capabilities particularly its Information and Communications Technology Capability;

WHEREAS, towards this end, the Philippine National Police (PNP) has the with necessary funds to procure CCTV and other ICT-related equipment for the Philippine National Police (PNP) Command Center and Philippine National Police (RNP) National Operation Center;

WHEREAS, to maximize and optimize the capabilities and use of the ICT equipment procured by the Philippine National Police (PNP), there is a need to install electronic equipment in areas specifically chosen due to their strategic locations within Metro Manila;

WHEREAS, several locations in Muntinlupa City have been chosen for the installation of electronic equipment to support the said project;

WHEREAS, prior coordination was already made with the City Government of Muntinlupa thru the Muntinlupa City Disaster Risk Reduction and Management Office;

WHEREAS, under the *Memorandum of Agreement (MOA)*, the City Government of Muntinlupa will allow the Philippine National Police:

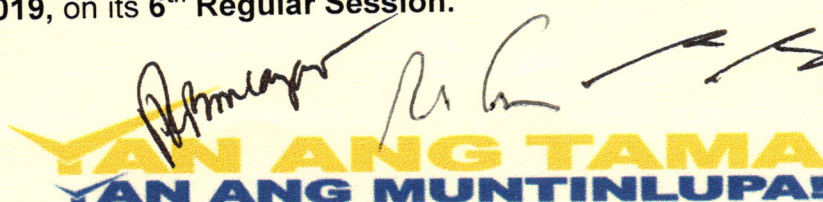
- a. *To install various electronic equipment, in different locations in Muntinlupa City.*
- b. *The Philippine National Police will ensure that the installation will pose no danger to nearby the buildings and their occupants;*
- c. *The Philippine National Police will furnish the City with the names of its personnel who will be authorized to access and maintain the installation equipment.*
- d. *The Philippine National Police shall bear the cost of maintenance and utility expenses that may be incurred on the electronic device to be installed.*
- e. *The City Government shall have access to the CCTV recording upon prior request to the PNP.*

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 9th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter into and sign in behalf of the City Government of Muntinlupa a Memorandum of Agreement (MOA) with **Philippine National Police (PNP)** concerning the installation of electronic equipment **Closed Circuit TV Cameras (CCTVs)** in and around the City of Muntinlupa.

APPROVED, by 9th Sangguniang Panlungsod of Muntinlupa this 5th day of August, 2019, on its 6th Regular Session.
