WHEREAS, Section 16, of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "*local government units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, an those which are essential to the promotion of the general welfare; shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety and safety, enhance the right of the people of a balance ecology, encourage and support the development of appropriate and self reliant, scientific and technological capabilities, improve public morals, enhance economic property and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.*";

WHEREAS, the *Skyway Extension Project* is now being implemented from the existing main line Toll Plaza to Susan Heights Toll Plaza area;

WHEREAS, the project duration is from *June 2019 to December 2020* at a cost of *Ten Billion Pesos (Php10,000,000,000.00)*;

WHEREAS, such construction will seriously affect the flow of traffic in and around the Alabang Viaduct Area, including *T. Montillano St., East and West Service Road, Alabang-Zapote Road*, and all entry and exit points in the said area;

WHEREAS, during the public hearing conducted last *August 6, 2019*, the *Muntinlupa Traffic Management Bureau (MTMB)* observed the following affected posts along the Alabang Viaduct to wit: South Bound Pier 49 from the East Service Road and near the Toll Plaza; Pier 50, in front of Amore; Pier 59 center; Pier 60 in front of Sogo Hotel; Pier 60, 61, 62 the fifth (5th) lane, that will generate traffic congestion underneath the Alabang Viaduct;

WHEREAS, no concrete plan on the design of the project has been submitted to the City Government, including location of posts and entry and exit points of the extension project;

WHEREAS, no traffic impact assessment has been done on the project and how the traffic plan shall be implemented;

WHEREAS, there is an urgent need to coordinate first with the *Muntinlupa Traffic Management Bureau (MTMB)* and *Engineering Department* to address the situation;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 9th Sangguniang Panlungsod of Muntinlupa, to recommend the temporary stoppage of the construction of the Skyway extension project until a concrete plan on the design is submitted and the traffic impact assessment is completed.

RESOLVED FURTHER, that copy of this resolution be given the Contractors of Skyway Extension Project, the Philippine National Railways (PNR), the Skyway and the Department of Transportation (DOTR);
