WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates, as a primary operative principle of decentralization, the establishment of accountable efficient and dynamic organizational structure and operating mechanism in the Local Government that will meet the priority needs and service requirements of its constituents;

WHEREAS, as sanctioned by the Local Government Code, the structure and operating mechanism include the establishment and operation of Local Economic Enterprise (LEE);

WHEREAS, the Local Economic Enterprises (LEEs) which are owned by the Local Government Units (LGUs) generate revenue/income through the sales of goods and services;

WHEREAS, Local Government Units (LGUs), through Sanggunian may create the Local Economic Enterprises (LEEs) for the purpose of improving production and delivery of services and are expected to generate the bulk of their income and include local hospitals and local colleges;

WHEREAS, on October 29, 2019, the City Mayor Atty. Jaime R. Fresnedi endorsed to the Sangguniang Panlungsod of Muntinlupa the following documents:

1. Copy of Resolution No. 014, Series of 2019, issued by the Pamantasan ng Lungsod ng Muntinlupa Board of Regents dated October 15, 2019, wherein the Board approves the recommendation of the University Council to create the Pamantasan ng Lungsod ng Muntinlupa (PLMun) as Local Economic Enterprises.

WHEREAS, the creation of Lungsod ng Muntinlupa as Local Economic Enterprise for the purpose of establishing, developing, operating, maintaining and managing suitable University Enterprise to enhance the income of the University Effective Calendar Year 2020;

WHEREAS, on **September 27, 2019**, the University Council has issued a Resolution approving the proposed creation of the Pamantasan ng Lungsod ng Muntinlupa as Local Economic Enterprise on the basis of the Executive Summary of PLMun as an educational institution and an economic enterprise presented and submitted by Ms. Victoria A. Mendoza, Finance Office, consisting of the following:

1. **Objectives of PLMun as an economic enterprise;**
2. **Project Profit and Loss for the Year 2020-2024;**
3. **Estimated Cash Balance for the years 2020-2024;**
4. **Project Balance Sheet for the year 2020-2024;**
5. **Personnel Plan;**

WHEREAS, on **October 15, 2019**, Dr. Elena E. Presnedi, OIC, PLMun, presented and discussed before the Board the 5-year business plan of PLMun, with supporting documents, justifying the creation of the Pamantasan ng Lungsod ng Muntinlupa as Local Economic Enterprises, its Executive Summary which consist of the following data:

1. **Profile of the Local Government Unit (LGU);**
2. **Product or Service Description;**
3. **Market Analysis;**
4. **Marketing and Sales Strategy;**
5. **Management and Personnel Plan;**
6. **Financial Projections;**

A copy of the 5-year business plan of PLMun is herto attached marked as Annex "B" and made an integral part hereof;

WHEREAS, the conversion of Muntinlupa Polytechnic College into a local university will ensure personnel autonomy, property autonomy and fiscal in order to attain its vision, mission, objectives;

WHEREAS, Section 22. of Republic Act No. 7160, otherwise known as the New Local Government Code of 1991 provides that, Section 22. Corporate Powers:

WHEREAS, Section 325 of the said Local Government Code further provides that, General Limitations – the use of the provincial, city, and municipal funds shall be subject to the following limitations:

- a) *Xxx. The appropriations for the salaries, wages, representation and transportation allowances of officials and employees of the public utilities and economic enterprises owned, operated and maintained, by the local government unit concerned shall not be included in the annual budget or in the computation in the maximum amount for personal services of such economic enterprises shall be charged to their respective budgets.*

WHEREAS, based on the aforementioned provision of the local government code of 1991, *Pamantasan ng Lungsod ng Muntinlupa (PLMun)* may be considered as Local Economic Enterprise;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 9th Sangguniang Panlungsod of Muntinlupa, to convert the *Pamantasan ng Lungsod ng Muntinlupa (PLMun)* Local Economic Enterprise.

ENACTED, by 9th Sangguniang Panlungsod of Muntinlupa this 12th day of November, 2019, on its 1st Special Session.
