WHEREAS, Section 34 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "**Local Government Units shall promote the establishment and operations of people's and non-government organizations to become active partners in the pursuit of local autonomy**";

WHEREAS, Section 11 of **Ordinance No. 05-040**, "**any organization and its officers who are found to have used its accreditation for illegal purposes shall be prohibited from seeking accreditation and shall be blacklisted. Any organization violating the terms and conditions of its accreditation shall not be renewed and shall not enjoy the privileges provided for under this ordinance**";

WHEREAS, Section 7 of Ordinance No. 05-040, states that, "**the organization duly accredited by the Sangguniang Panlungsod may be entitled to assistance, financial or otherwise for its economic, socially-oriented, environmental, environmental or cultural projects to be implemented within the territorial jurisdiction of Muntinlupa City. xxx**";

WHEREAS, Ordinance No. 05-040 as amended by City Ordinance No. 06-093, states that, "**the organization duly accredited by the Sangguniang Panlungsod shall enjoy the privileges of an accredited organization for three (3) years from the time the Chief Executive signs the resolution for accreditation. Provided that:**

- I. The organization must still submit on an annual basis a copy of its annual report to the Securities and Exchange Commission (SEC), or a copy of the annual report to the Housing and Land Use Regulatory Board (HLURB), or Cooperative Development Authority (CDA) or whatever national agency which requires submission of annual report.
- II. The organization must still submit the annual or biennial report as the case may be, of the results of the elections of its new set of officers or Board of Directors.
- III. The organization must still submit an annual financial report and annual accomplishment report as required by the ordinance

WHEREAS, the Sto. Niño Village 3 Homeowners' Association, Inc., complied all the requirements required by Ordinance No. 05-040 as amended by Ordinance No. 06-093;

WHEREAS, Section 6 of Ordinance No. 05-040, states that this accreditation is renewable two (2) months before the date of its approval by the Chief Executive;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to grant the accreditation to Sto. Niño Village 3 Homeowners' Association, Inc., located at Block 7, Lot 39, Phase 3, St., Mary Street, Sto. Niño Village, Barangay Tunasan, Muntinlupa City.
