WHEREAS, under the Local Government Code of 1991, as amended, *“the City Council as the legislative body of the City has the power to determine the position, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from City Funds”*;

WHEREAS, Budget Circular No. 2016-4 April 18, 2016, the subject of which is *“Updated Rules and Regulations on the grant of the Year-End Bonus and Cash Gift for FY 2016 and years thereafter, provides, exemption to entitlement thereto under 4.3 that those hired without employer-employee relationships and funded from Non-Personnel Services appropriations/budgets, which may include, among others: “(4) Individual and groups of people whose services are engaged through job orders, contract of services, or other similarly situated.”*

WHEREAS, *Part-Time Faculty Teachers and Staff of PLMun* belong to the exemption above-said that they are considered not entitled to the Year-End Bonus and Cash Gift;

WHEREAS, CSC-COA-DBM Joint Circular No. 1, s2017, and its amendments, provides for a premium of 20% of the wages/salary of *Job Order or Contract of Service*, which may be paid on monthly basis, in lump sum or in tranches as, may be stated in the agreement or contract with the agency;

WHEREAS, Faculty Teachers, and staff were given additional allowance by the City Mayor in the past during yuletide season to augment their needs and in the spirit of thanksgiving and gift-giving;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by 9th Sangguniang Panlungsod of Muntinlupa, into Session assembled that:

SECTION 1. An additional premium pay in the amount of **Five Thousand Pesos (Php5,000.00)** each shall be given to Part-Time Faculty members and staff of Pamantasan ng Lungsod ng Muntinlupa (PLMun).

SECTION 2. This additional **20% premium pay** shall be given to earlier than **15th** day of **December 2019**.

SECTION 3. The Fund for the payment of this premium shall be taken from source other that the personnel service.

SECTION 4. This ordinance shall be considered as an amendment and/or supplement to the existing contract of service of Part-Time Faculty members and staff of PLMun.

SECTION 5. This ordinance shall take effect immediately after its approval.
