AN ORDINANCE ALLOCATING FIVE THOUSAND PESOS (PHP5,000.00) CASH INCENTIVES TO EACH OF THE TEN NON-EMPLOYEE MEMBER OF THE HIMIG NG MUNTINLUPA.

WHEREAS, under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, as amended, provides the, "every local government unit shall exercise the power expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for the efficient and effective governance, and those which are essential to the promotion of the general welfare.";

WHEREAS, the 9th Sangguniang Panlungsod enacted Ordinance No. 19-036, granting Five Thousand Pesos (Php5,000.00) to personnel whose employee and employer relationship with the City Government of Muntinlupa is absent;

WHEREAS, the Ten (10) Non-Employee Members of Himig ng Muntinlupa, neither belong to the classification as stated above, their services being voluntary in nature;

WHEREAS, the City Government of Muntinlupa, based on the General Welfare Clause, deemed it proper that Ten (10) Non-Employee Members of Himig Muntinlupa be granted cash incentive amounting to Five Thousand Pesos (Php5,000.00) each for their participation in the Himig ng Muntinlupa;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by 9th Sangguniang Panlungsod, in Special Session assembled that:

SECTION 1. Title – This ordinance shall be known as "An ordinance allocating Five Thousand Pesos (Php5,000.00) cash incentives to each of the ten (10) non-employee members of the Himig Ng Muntinlupa."

SECTION 2. Coverage – This Cash Incentive shall be given to Ten (10) Non-Employment of the Himig ng Muntinlupa.

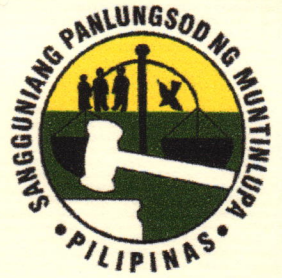

SECTION 3. Appropriation – The total amount of **Fifty Thousand Pesos (Php50,000.00)** of Cash Incentive for the ten non-employees of the Himig ng Muntinlupa shall be taken from the 2019 Executive Budget (Tourism, Culture and the Arts Office).

SECTION 4. Effectivity Clause - This ordinance shall take effect immediately upon its approval.
