A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI IN BEHALF OF THE CITY GOVERNMENT TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) – NATIONAL CAPITAL REGION (NCR) FOR A SPECIAL PROJECT SECTION FOR SUPPLEMENTAL FEEDING PROGRAM TO IMPLEMENT R.A. 11037 KNOWN AS “MASUSTANSYANG PAGKAIN PARA SA BATANG PILIPINO.”

WHEREAS, Article 86 (v)(1)(vi) and Article 86 (b)(1)(viii) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, “the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, “xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned.”;

WHEREAS, the state in its endeavour to address malnutrition among children, enacted Republic Act No. 11037 otherwise known as the “Masustansyang Pagkain para sa Batang Pilipino of 2018”;

WHEREAS, Republic Act No. 11037, mandates the institutionalization of a comprehensive National Feeding Program for undernourished children in public day care, kindergarten and elementary schools noting the confirmed link between food and nutrition and the capacity of children to develop and learn;

WHEREAS, the DSWD in its mandate to provide social welfare and development programs, particularly through technical assistance and resource augmentation, has been providing community-based nutrition programs and services such as **Food for School and Healthy Start Feeding Program** in child development centers at the local government units (LGUs); partnership with the non-government organization (NGOs) is employed to promote community participation;

WHEREAS, as sanctioned by Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "**the local government units, provide health and social welfare services to its constituents, which includes the programs and projects on child and youth welfare.**";

WHEREAS, the Supplementary Feeding Program, herein referred to as the "**Program**", is the provision to targeted children of at least one (1) fortified meal for a period of not less than One Hundred Twenty (120) days in a year; the amount of Php15.00 per children/per day is allocated for a meal composed of rice and viand or milk and alternative meals';

WHEREAS, one of the responsibilities of the DSWD- Field Office is to: Manage and coordinate/supervise the regional/municipal implementation of the Supplementary Feeding Program;

WHEREAS, before the start of the feeding program the Local Government shall carry out initial weighting of the beneficiaries and submit report on nutritional status of children beneficiaries; and coordinate with the City Health Office for the provision of Vitamin A supplementation to the children beneficiaries and ensure they undergo deworming a **Child Development Centers (CDCs)**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi in behalf of the City Government to sign and enter into a Memorandum of Understanding (MOU) with the Department of Social Welfare and Development (DSWD) – National Capital Region (NCR) for a special project section for Supplemental Feeding Program to Implement R.A. 11037 known as "**Masustansyang Pagkain Para Sa Batang Pilipino.**"

RESOLVED FURTHER, that copy of this resolution be given to the Office of the Department of Social Welfare and Development (DSWD-National Capital Region (NCR) for their information.
