A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO AND SIGN THE DEED OF DONATION OF 900 MODULAR TENTS TO NINE (9) BARANGAYS IN THE CITY OF MUNTINLUPA FOR THEIR CUSTODY AND SAFE KEEPING.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, **"every Local Government Units shall exercise the powers expressly granted, those necessary implied therefrom, as well as power necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare"**;

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances."**;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, **"xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned."**;

WHEREAS, the City Government of Muntinlupa purchased 900 units Modular Tents particularly described as follows:

WHEREAS, the City Government realizes the need of Modular Tents for each barangay for any man-made and natural calamities to serve the growing needs of their constituents;

WHEREAS, the City Government of Muntinlupa shall enter into a Deed of Donation for the donation of 900 Modular Tents to be distributed to each nine (9) Barangays on the basis of their respective population as follows:

WHEREAS, the Barangays need Modular Tents to enhance its programs on security and safety of their constituents and to respond more effectively to any natural man-mad calamities;

WHEREAS, the Barangay Chairman, who will accept the Modular Tents shall comply with the undertakings under the terms and conditions setforth in the Deed of Donation with regards to the taking care of the said Modular Tents;

RESOLVED FURTHER, a) to mandate the City Disaster Risk Reduction Management Office (DRRMO) to conduct regular monitoring of the donated Modular Tents which shall be used exclusively for calamities; b) to provide copies of this Resolution to the Chairmen of the nine (9) Barangays and to all other offices concerned for their information and guidance.

RESOLVED, FINALLY, that copy of Deed of Donation shall form part of this approved Resolution.

ADOPTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 28th day of October 2019, on its 18th Regular Session.
