WHEREAS, the Astra Zeneca will work on the construction of a nebulization unit within the parameters agreed with Ospital ng Muntinlupa and support the continuing medical education of hospital healthcare professionals on the latest updates on asthma management;

WHEREAS, the only requirement for Ospital ng Muntinlupa is to designate the suitable area for the nebulization corner and allow the training of the appropriate health professional to help run the operations of the nebulization corner;

WHEREAS, the term of the Memorandum of Agreement shall take effect upon signing and shall remain valid and in force for a period of one (1) year;

WHEREAS, Dr. Edwin Dimataac, Ospital ng Muntinlupa (OsMun) Director, confirmed there is an available space on the 2nd Floor of Ospital ng Muntinlupa for the Asthma Nebulization Corner (ANC);

WHEREAS, the City Government of Muntinlupa shall:

- a. **Collaboratively identify and designate with the Second Party suitable areas to set up a nebulization corner in the Ospital ng Muntinlupa;**
- b. **Work with the Second Party in the training of the appropriate healthcare professionals (doctors, nurses, and pharmacists) to help run the operations of the nebulization corner;**
- c. **Explore the development of hospital guidelines and protocols in the management of asthma patients;**
- d. **Explore the assignment of staff roles in the nebulization corner operations**
- e. **Develop mechanism for the long-term supply of medicines for the nebulization corner aligned to rules of the hospital**
- f. **Provide such other support as may be available to ensure the success of the undertakings under this MOA.**
- g. **Can discontinue the nebulization corner and reassign the space should the project not serve its purpose, given adequate advance notice of 2 months and with prior discussion with second party.**

WHEREAS, the Astra Zeneca shall provide support mechanism to help support the development of an **Asthma Nebulization Corner (ANC)** for asthma patients of Ospital ng Muntinlupa;

WHEREAS, the Astra Zeneca shall:

- h. **Explore partnership and processes to provide necessary support to the setting up of the nebulization corner, including, but not limited to the provision of nebulizers for the nebulization corner**
- i. **Work on the construction of the nebulization corner within parameters agreed between the 2 parties**
- j. **Develop a patient awareness and education program**
