A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH DUMDUMA CONSTRUCTION & TRADING CORPORATION AND STARCROSS CONSTRUCTION INC., FOR THE PROJECT CONSTRUCTION OF COLLEGE BUILDING (PHASE 3) LOCATED AT PAMANTASAN NG LUNGSOD NG MUNTINLUPA (PLMUN), NBP RESERVATION, BARANGAY POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF NINETEEN MILLION NINE HUNDRED SIXTY SEVEN THOUSAND ONE HUNDRED TWENTY TWO PESOS (PHP19,967,122.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2019 EXECUTIVE BUDGET UNDER INFRA FUND.

**WHEREAS**, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid for the project **College Building (Phase 3)** located at **Pamantasan ng Lungsod ng Muntinlupa (PLMun), NBP Reservation, Barangay Poblacion, Muntinlupa City** in a newspaper of nationwide general circulation, likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, two (2) bidders submitted their bid documents on March 28, 2019 and one bidder passed the preliminary examination of bid;

**WHEREAS**, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, the **Joint Venture of Dumduma Construction & Trading Corporation and Starcross Construction, Inc.**'s proposal has been found to be responsive;

**WHEREAS**, the amount appropriated for the said project shall be taken from the 2019 Executive Budget under Infra-Fund;

**WHEREAS**, the **Approved Budget for the Contract (ABC)** for the project construction of **College Building**, amounts to Nineteen Million Nine Hundred Ninety Seven Thousand Three Hundred Eighty Seven Pesos and 69/100 (**Php19,997,387.69**);

**WHEREAS**, the project was awarded to **Joint Venture of Dumduma Construction & Trading Corporation and Starcross Construction, Inc.**, being the responsive bidder for the project, **construction of College Building (Phase 3)** at Pamantasan ng Lungsod ng Muntinlupa (PLMun), NBP Reservation, Barangay Poblacion, Muntinlupa City;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 8<sup>TH</sup> Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Joint Venture of Dumduma Construction & Trading Corporation and Starcross Construction, Inc.**, for the project **construction of College Building (Phase 3)** located at Pamantasan ng Lungsod ng Muntinlupa (PLMun), NBP Reservation, Barangay Poblacion, Muntinlupa City in the amount of **Nineteen Million Nine Hundred Sixty Seven Thousand One Hundred Twenty Two Pesos (PHP19,967,122.00)** which amount shall be taken from the 2019 Executive Budget under **Infra-Fund**.
