A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH ROSTEL CONSTRUCTION & SUPPLY FOR THE PROJECT INSTALLATION OF RENEWABLE ENERGY HARVESTING FEATURES (SOLAR PANEL) LOCATED AT COLEGIO DE MUNTINLUPA, POSADAS, BARANGAY SUCAT, MUNTINLUPA CITY IN THE AMOUNT OF TWENTY EIGHT MILLION FIVE HUNDRED EIGHTY SIX THOUSAND FOUR HUNDRED EIGHTY EIGHT PESOS (PHP28,586,488.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2018 SUPPLEMENTAL BUDGET AND 5% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (70% PREPAREDNESS).

WHEREAS, BAC Resolution No. 2019-INFRA21, stated that despite passing the Preliminary examination of bids and having been the lowest bidder Equator Energy and Airnergy and Renewal bid were found to be Non Responsive thereby the next qualified and responsive bid was awarded to Rostel Construction & Supply;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **Rostel Construction & Supply's**, its bid has been found to be responsive **Approved Budget for the Contract (ABC) Php28,592,846.07**;

WHEREAS, the project was awarded to **Rostel Construction & Supply**, who being the responsive bidder for the project, Installation of Renewable Energy Harvesting Features (Solar Panel) located at Colegio De Muntinlupa, Posadas, Barangay Sucat, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8<sup>TH</sup> Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Rostel Construction & Supply** for the project Installation Of Renewable Energy Harvesting Features (Solar Panel) located at Colegio De Muntinlupa, Posadas, Barangay Sucat, Muntinlupa City In The Amount of **Twenty Eight Million Five Hundred Eighty Six Thousand Four Hundred Eighty Eight Pesos (Php28,586,488.00)** which amount shall be taken from the 2018 Supplemental Budget and 5% Local Disaster Risk Reduction And Management Fund (LDRRMF) (70% Preparedness).
