WHEREAS, the Budget Office endorsed to the Sangguniang Panlungsod the Budget of Sangguniang Kabataan (SK) Alabang amounting to **Eleven Million Four Hundred Twenty-Nine Thousand Five Hundred Thirty-One Pesos and 70/100 (Php11,429,531.70)**;

WHEREAS, the Budget Office recommended the approval of the **Sangguniang Kabataan (SK) Budget of Barangay Alabang** as it has complied with the required documents, rules, and regulations, and relevant laws pertaining to budget;

WHEREAS, appropriation for SK shall be disbursed in accordance with Art. 425 of the IRR, R.A. 7160 and R.A. 10742 otherwise known as the Sangguniang Kabataan Reform Act of 2015 and its IRR, and DBM-DILG-NYC JMC No. 1 Series of 2019;

WHEREAS, all procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provision of R.A No.9184 (Government Procurement Reform Act) and its Revised IRR; and prior clearances from pertinent agencies as maybe appropriate /needed. In addition, all procurement shall be included in the duly approved Annual Procurement Plan;

WHEREAS, **Sangguniang Kabataan (SK) Alabang** Budget shall be available exclusively for the specific purposes for which they have been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of SK Treasury except in pursuance of an Appropriation Ordinance or Law;
