ORDINANCE NO. 2020-192

AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 AMOUNTING TO (PHP154,230,178.11) TO COVER THE STATUTORY AND CONTRACTUAL OBLIGATIONS COVERING THE 20% COMMUNITY DEVELOPMENT FUND (CDF) FOR VARIOUS CONSTRUCTION PROJECTS WHICH AMOUNT SHALL BE TAKEN FROM THE SAVINGS-UNEXPENDED BALANCE OF THE CITY AND ADOPTING THE CY 2020 ANNUAL INVESTMENT PROGRAM (AIP)

WHEREAS, Section 16 of the Republic Act No. 7160 or the Local Government Code of 1991 (LGC) provides that "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Section 319 of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that, "**on or before the end of the current fiscal year, the Sanggunian concerned shall enact, through an ordinance, the annual budget of the Local Government Units (LGUs) for the ensuing fiscal year on the basis of the estimates of income and expenditures submitted by the Local Chief Executive**";

WHEREAS, pursuant to Article 99, 2(i) of Implementing Rules and Regulations of the LGC of 1991, the Sangguniang Panlungsod, "**shall approve the annual and supplemental budgets of the city government and appropriate funds for specific programs, projects, services and activities of the city or for other purposes not contrary to law, in order to promote the welfare of the city and its inhabitants**";

WHEREAS, Sections 312 and 319 of the LGC and Article 417 of its Implementing Rules and Regulations (LGC-IRR), as amended by Administrative Order (A.O.) No. 47, s. 1993, allow changes in the Annual Budget of the LGU through supplemental budgets under specified circumstances;

WHEREAS, a Statement of Supplemental Appropriation for Calendar Year 2020, Supplemental Budget No. 2 amounting to Php152,230,178.11 for various construction projects was endorsed by the Local Chief Executive with the Engineering Department as implementing Office;

WHEREAS, as certified by Local Budget, Local Accountant and Local Treasurer as of December 23, 2020, there is an available fund coming from Unexpended Balance amounting to **One Hundred Fifty-Four Million, Two Hundred Thirty Thousand One Hundred Seventy-Eight Pesos and 11/100** incorporated in the Statement of Funding Sources, Supplemental Budget for Fiscal Year 2020 of the City Government of Muntinlupa (LBP Form No.8) as follows:

NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panlungsod in session assembled that:

SECTION 1. Short Title. This Ordinance shall be known as the Supplemental Budget No. 2", amounting to One Hundred Fifty-Four Million Two Hundred Thirty Thousand One Hundred Seventy-Eight Pesos (php154,230,178.11) to cover the statutory and contractual obligations covering the 20% Community Development Fund (CDF) for various construction projects which amount shall be taken from the Savings-Unexpended Balance of the city and adopting the CY 2020 Supplemental Annual Investment Program (AIP).

SECTION 2. The Supplemental Budget No. 2 amounting to One Hundred Fifty-Four Million Two Hundred Thirty Thousand One Hundred Seventy-Eight Pesos (php154,230,178.11) is appropriated and allocated as follows:
